v. Defibrillator Training Event (New Defibrillator).

The Dinorben Arms hosted the defibrillator training on the 27th February. The event was attended by 13 people and all feedback was very positive. A further 17 people are expected to attend the next event on the 19th March from 1pm-3pm at the Salusbury Arms in Tremeirchion. An email was sent to the Dinorben Arms to thank them for hosting the event and supplying free tea and coffee.

Chris West (NHS Executive) who provided the training, inspected Ysgol Bodfari defibrillator and confirmed it is in good condition and should be viable for another 5 years. He also confirmed it contained the option to switch the defibrillator to child mode. Further training events are planned for 2026; these will be hosted in the Cym and Waen area but residents of Bodfari will be included in the advertising for attendees.

RP stated she is installing a new defibrillator outside the Oriel Gallery in Bodfari. BCC agreed they would fund the replacement pads for this new machine as they do for the Ysgol Bodfari Defibrillator as they are vital equipment for Bodfari residents. Councillor Evans stated he would speak to DCC to see if there were any commuted sums available for this defibrillator installation.

6. County Councillor's Report.

9. Village Playground and Park

Briefing paper prepared by HE to summarise the advice and associated quotes from 3 arborists for work in the park. Each arborist's proposal was different. The briefing paper also advised what budget was available to spend. Councillors resolved to get a further quote from Aerial Arborists that is more comparable to the other 2 quotes received. It was also decided to check if the tree issues mentioned in the Play Inspection Report are included in the initial quotes.

Ask Phil Lloyd and Cambrian if the tree issues mentioned in park report are included in their quotes and if not, send a revised quote – SD.

v. New Fencing Recreation Ground.

PB had studied the Recreation Ground deeds and noted the fencing on the road side of the Recreation Ground appears to be on BCC land. The fencing has been intentionally damaged to create an alternative entrance and exit to the Recreation Ground from the road that leads from the Dinorben Arms to the main road. This is dangerous, and all previously erected signs are damaged and being ignored. A permanent solution is needed. In addition, behind this fence there is a copse that is full of brambles, and another internal fence on the Recreation Ground that has also been damaged. BCC estimate that the cost to replace the external fencing on the road side would be approximately £48 per metre plus labour, with additional costs associated with clearing the copse and removing the internal fence, then installing new metal fencing. Clarification is needed as to whether responsibility for the replacement / repair of this fencing sits with BCC or DCC.

Action:

Approach DCC to report the damaged fencing – CE.

Crocus Display in Full Bloom at Plas Newydd

Llangollen's historic Plas Newydd has once again been transformed into a stunning sea of purple and white as thousands of crocuses burst into bloom across its lawns.

Visitors to the picturesque site are being treated to a spectacular display of colour, marking the arrival of spring in the heart of North Wales.

Crocuses are among the first flowers to bloom in late winter to early spring, often appearing as early as February.

The vibrant flowers provide a crucial source of nectar and pollen for early-emerging bees and other pollinators.

The gardens at Plas Newydd are renowned for their romantic setting and rich history, famously associated with the Ladies of Llangollen. Lady Eleanor Butler and Miss Sarah Ponsonby made the site their home in the late 18th century and were lovers of nature and gardening.

UK's first electric 4x4 coming to maintain Denbighshire landscapes

A UK home grown electric powered all-terrain vehicle is set to take to the hills of Denbighshire and the surrounding areas.

Denbighshire County Council's Fleet Department has secured a Munro Series M electric 4x4 vehicle to support the Clwydian Range and Dee Valley National Landscapes team.

The vehicle has been supported in part by gap funding from the Welsh Government's Energy Service.

Currently in production, the Scottish produced all-terrain vehicle will replace a fossil fuel powered pick-up truck that has come to the end of its fleet life. It will be based at Loggerheads Country Park.

Countryside rangers will use the Series M, the first series production vehicle to come from Scotland for more than 40 years, to support their daily role in managing the landscapes in their area.

The vehicle has been picked for tackling the terrain of the Clwydians and other hilly sites thanks to its thorough testing on all types of off-road situations and its ability to tackle gradients above 40 degrees.

Introducing the Munro is part of Denbighshire County Council's continued drive to reduce fleet carbon emissions, improve air quality and lower long-term maintenance and service costs by replacing end of life vehicles with proven EV equivalents.

Councillor Barry Mellor, Lead Member for Environment and Transport said: "The Council remains committed to tackling the Climate and Ecological Emergency declared in 2019 and it's great to see a UK developed EV replacing the end of life 4x4 fossil fuel driven vehicle. This will provide a robust all terrain service for the rangers while providing greener and cleaner mileage at a lower fuel and general maintenance cost as well. A fitting vehicle to operate within our Area of Outstanding Natural Beauty."
